THINGS TO DO *IF A STORM IS COMING*

GATHER THE FOLLOWING ITEMS:

- 3-5 Day Supply of Water (1 Gallon Per Person Per Day)
- First Aid Kit, Flashlights & Tool Kit
- Blankets
- Extra Clothes
- Toilet Paper & Paper Towels
- Portable Radio (Preferably with AM Reception)
- Batteries & Portable Phone Chargers
- 3-5 Day Supply of Non-Perishable Foods
- Baby Supplies (Formula, Wipes & Diapers)
- Lighter/Matches
- Pet Supplies (Food, Water, & Litter)
- Cash
- Extra Medication

GATHER & STORE THESE IMPORTANT DOCUMENTS IN A WATERPROOF CONTAINER:

- Valid IDs
- Passports
- Birth Certificates
- Deeds/ Property Titles
- Car Registration/Titles
- Copy of Your Pre-Loss Home Inventory Sheet/Photos
- Copy of Your Insurance Policy
